TERMS OF USE OF SPIDTECH.COM

IMPORTANT POINT. FIRSTLY, YOU AGREE THAT YOU ARE AT LEAST 19 YEARS OLD AND THAT YOU ARE LEGALLY ABLE TO ENTER INTO THIS AGREEMENT.

1. **BINDING AGREEMENT.** This is a binding agreement, which means you agree to abide by the rules of this agreement even by just using the Internet site located at www.spidtech.com or its sub domains, if any, (the “Site”) or any services provided in connection with the Site (the “Service”). You agree to abide by these Terms of Use. It should be borne in mind that these terms may be changed or amended by SPIDTECH Structural Software, Inc. (SPIDTECH) from time to time in its sole discretion. SPIDTECH will post a notice on the Site any time these Terms of Use are decided to be changed. It is your responsibility to review these Terms of Use periodically, and if at any time you find these Terms of Use unacceptable, you must immediately leave the Site and cease all use of the SPIDTECH services and the Site.
